From the Mayor's Office

I would like to take this opportunity to wish everyone a Happy New Year, and to say that I think 2013 will be a banner year for the City of Talent.

On January 3rd, the City Council made an historic decision to approve a three-lane design concept for the section of Highway 99 from Rapp Road to Creel Road. A recent "Talent Area Road Diet Analysis" prepared for the Oregon Department of Transportation by a private consultant indicates that a three-lane concept will provide some key safety features while handling the projected traffic load for at least the next twenty years. It will also be considerably less expensive than a five-lane concept. This project has been a long time in coming, and I must say that without the help from Art Anderson and the Oregon Department of Transportation putting together a funding package, this project would still be just a dream. The next step will be to start the design process which of course will include a lot of public input. We could see construction start as soon as 2015. Contact City Hall if you would like to see the "Talent Area Road Diet Analysis".

Another key decision the City Council made on January 3rd was to make the final approval for a zone change on the old Wal-Mart property. This decision will allow Brammo, an electric motorcycle manufacturer, to proceed with the renovation process for this facility. I think I can speak for most everyone in Talent by saying -- Welcome Brammo to our community. We are looking forward to a long and prosperous relationship.

With all of these benefits who could see a downside to this companionship? Most people are responsible and courteous enough to clean up after their canine companion while in public spaces, but recently there have been a few incidents that have been brought to my attention about this particular issue. I thought this would be a great way to remind everyone that the City of Talent does have a nuisance Ordinance addressing this situation and it states the following:

Any person, with the exception of a sightless person, responsible for any dog, shall be in possession of tools for the removal of and shall remove, excrement deposited by the dog in any public area not designated to receive those wastes, including but not limited to streets, sidewalks, parking strips, trails or roads paralleling ditches, swales, culverts, canals, railroad tracks or similar facilities.

Talent PD News By Chief Mike Moran

December was a very wet month and this information will be very useful if the heavy rains continue and the creeks rise. In an emergency you must be responsible to assure your own safety. In a large scale emergency, help may not be able to reach you. If you have taken some steps to prepare, you are way ahead of whatever disaster comes. Hurricane Sandy was an extreme, but flooding in your neighborhood or living with no utilities for a few days can be frightening and must be prepared for.

Ultimately, your safety depends on your willingness to be ready and take action when disaster strikes.

When you hear warnings of a potential disaster, having a "Ready to Go Kit" prepared will give you a head start on evacuating quickly. The kit should include any medications and supplements you will need if you must

leave your home for a few ours or a few days. Other personal care items ready to go are a good idea too.

Have your phones, extra keys, wallets and important documents in a central place ready to quickly go with you.

Most importantly, if emergency personnel advise you to evacuate, do so. The reports of people who ignored warnings and lost their lives during Hurricane Sandy were unsettling. Resources will be stretched thin and those who chose to remain in hazardous situations during a major emergency will potentially not be reached.

If you will have difficulty evacuating, plan now and register with the Jackson County Disaster Registry. This is a different program than the Jackson County Citizen Alert which I will discuss below. For those who will require extra assistance, call 541-664-6676 ext. 379 for more information on this. They can alert emergency personnel that you will need extra aid. It is also a good idea to meet ahead of time with neighbors and collaborate on helping each other. Having a pre-arranged support system for getting



you and your pets to safety is crucial.

For everyone, please think about having extra water in your home before there is a need. Also, consider having food that can be stored and that can be prepared in the event utilities are cut off.

Plus, if you have not signed up for Citizen Alert is a program to be able to alert you via cell phone, work phone, E-mail or text of warnings issued for your area. Landlines are already included in this 911 database. For more information on how this is a benefit to you, go to www.jacksoncounty.org/alert

On another topic, I continue to receive calls about dogs not on a leash. If you are a person walking a dog anywhere in the city on streets, sidewalks vacant lots, school yards and especially city parks, except inside the fence at the dog park, your dog must be on a leash. Being on "verbal command" does not meet the requirement of being on a leash. The leash also must be no longer than 6 feet. The Police Department has given out many warnings on this but be aware that you can receive a citation for this without a prior warning. Please keep your dog on a leash for everyone's safety.

Here is a parking tip. Please do not park in your driveway across the sidewalk. We have so many kids who walk to school, dog walkers and runners who use the sidewalk but have to detour into the street if the side walk is blocked. It is a safety issue

and it is a violation of city code and state law. If the citation is a parking ticket the cost is \$20. If it is written on a regular ticket issued to your vehicle, it is a \$110 fine. Either can be issued.
