My name is Sarah Burns - <u>www.sarahfburns.com</u>. I have a studio in Talent called Project Space where I teach art classes and hold pop-up art shows. I grew up here in Southern Oregon and currently live in Phoenix.

This original oil painting was made en plein air in Spring of 2020, just as the COVID 19 pandemic was beginning. That was just the start of an immensely disruptive year for the small town of Talent, Oregon. Six months after this was painted, the massively destructive Almeda Fire would burn 14 miles of homes, businesses, and landscape, including the scene in this oil painting.

I then made the next painting, two years after the Almeda Fire. The sun is setting and there is wildfire smoke in the air, causing the sun to set in oranges and pinks. The mood is somber, but not depressing. It's meant to acknowledge and memorialize the event in a healing way.

Another purpose I have in creating these paintings is to chart the changes our valley experiences over time. The field in this scene was pear orchards about 15 years ago and is likely to have homes built here soon.

My paintings are created with archival methods and materials. They are meant to stand the test of time, to be part of a historical record. These pieces will easily last hundreds of years. The pieces have been framed in Maple by local fine furniture craftsman Jens Sehm.

My hope is they will have a public or semi-public place in Talent. I am interested in either donating them to the city or loaning them. I reviewed this over the weekend and have the following comments:

- 1. On the last page, where it lists potential funding sources, add a chart showing the amount of funding needed in each fiscal year to accomplish each project in the program of work. Will help with the budget process.
- 2. Just wondering if there has been some discussion about public art in the roundabout. The Garden Club leadership said that they are not planting that area because of potential hazardous materials from its past use.
- I started to do some technical investigation on painting a mural on the big water tank. Here is what I
 received so far from Joy Sears, Restoration Specialist at the Oregon Parks, and Recreation
 Department.

There are some things to think about when adding a mural to any structure. The first thing to think about is whether you are going to paint the mural directly on the concrete water tank or if the mural will be painted on another medium like boards or canvas. If you are going to paint the mural directly on the tank, I highly suggest using a mineral-based paint (made for masonry) instead of regular latex paint which won't weather well. Yes, the mineral-based paint is more expensive but it works so much better with the masonry. If you are going to paint the mural on another medium, you are going to need to create a large amount of attachments which may be problematic – you could think about the mural being like a large billboard and may rip off like a big sail.

Now, have you thought about the maintenance of the mural? Who is in charge of taking care of it? What happens if it's vandalized?

Our Stories Through Art (OSTA) Mural Selections Steps – OSTA feedback in June 2024 meeting:

Via OSTA meeting the following was discussed and adopted:

Priorities of Public Art Selection:

- 1. Outreach, Education, Promotion
- 2. Select Stories
- 3. Select Sites
- 4. Share with artists.
- 5. Criteria for submissions
- 6. Form Jury criteria based.
- 7. RFP (Request for Proposal)
- 8. Submissions (artwork, music, theatre, art)
- 9. Implementation

Outcomes:

- 1. Stories
- 2. Public Artworks
- 3. Talent as Art and Cultural Destination

Potential Steps from TPAC and OSTA Feedback:

(Possibly) Per location (each location would have different criteria including specific site, dimensions, type of background i.e.: cement, hardy board etc.)

- 1 Create 'criteria'/conditions for art including what can/cannot be done, no discrimination, appropriate for children etc. Also include rules such as date due, drop off location of email/google drive, size, medium, etc. including name, age and contact info on back of piece) Request an 'image sketch.'
- 2. The criterion will be submitted and approved by the city council and then become the rules for art jury to follow.
- 4 Obtain OSTA approved stories that could represent a theme of the mural from 'Our Stories Through Art' project (OSTA).
- 4. Create Social Media 'Call to the Artistic Talent Community' to submit art on behalf of the theme. (OSTA wants the community to submit art, not just artists/mural artists.)
- 5. After submissions:
 - a. Jury = TPAC to select up to 3-5 pieces for the mural(s)
 - b. TPAC recommends OSTA for approval.
 - c. TPAC lets artists know which were selected.
 - Could we use all/some art pieces submitted for flags on light poles, books, some kind of fundraising event for OSTA?
 - d. TPAC creates social media posts congratulating artists selected.
- 6. TPAC develops criteria for call to muralists (request for proposal RFP)
- 7. Call to muralists/community for creation of the art pieces.
 - a TPAC reviews and TPAC interview muralists for interest, skill, and costs
 - b TPAC recommends muralist, costs, and reasons for selection.
