#### ISSUE BEFORE THE BOARD

Budget Hearing for Fiscal Year 2024-2025 Approved Budget

#### **BACKGROUND**

The Agency Budget Committee approved the proposed FY2024-25 budget on May 8, 2024. Prior to the Board's consideration of the budget for adoption, the Board holds a public hearing on the approved budget to receive comments or questions from the public.

The Board will consider matters discussed at the hearing as they consider making any changes to the approved budget or adopting the approved budget. Once the budget hearing is held, the Board can make changes to the budget that was approved by the budget committee. The Board will take all available information into consideration when adopting the budget. This includes public testimony and any new information affecting the estimates of the upcoming year's resources or expenditures.

There are restrictions on the size of certain changes by the Board that may require additional steps before the resulting budget can be adopted. Specifically, if the Board decides to increase expenditures within a fund by more than 10%, the Agency will publish notice of and host a second budget hearing before the adjusted budget is adopted.

#### ISSUE BEFORE THE BOARD

Approval of Trailer Disposition Policy for the travel trailers at the Gateway Transitional Housing Site.

#### **BACKGROUND**

The Intermediate Housing Solution Program, established through Section 279 of House Bill 5006 (2021), is intended to provide intermediate housing to Labor Day 2020 wildfire survivors on their pathway to securing permanent housing recovery. The 53 travel trailers located at the Gateway Site were purchased by the State through its Oregon Housing and Community Services Department and provided to the non-profit Rogue Retreat as part of the Intermediate Housing Solution Program.

In February 2023, the Talent Urban Renewal Agency (TURA) took on ownership of the 53 travel trailers through Intergovernmental Agreement No. 7446 with the State. That agreement stipulates that TURA must provide a disposition plan for the travel trailers that has been approved by the State. In February 2023 TURA and OHCS retained ACCESS as the project site manager.

A Trailer Disposition Plan was developed in 2021, but was never approved by the TURA Board. Staff has worked with representatives of OHCS to update that document, which has also been reviewed by ACCESS. The Executive Director has also conferred with the Phoenix Talent School Superintendent and the Jackson County Fire District 5 Chief. ACCESS staff is now contacting Gateway residents concerning the possibility of relocating with the trailer they currently occupy.

A companion administrative document will be developed that will detail how the conveyance of the trailers will be handled.

#### DISPOSITION POLICY

Travel Trailers at the Gateway Transitional Housing Site

June 20, 2024

#### **BACKGOUND**

#### **DISPOSITION POLICY**

This is a policy document. Administrative details with respect to implementing this policy will be adopted in a separate, complementary document.

A trailer will be deemed ready for disposition when (a) the trailer remains vacant for more than 10 days, or (b) the trailer is deemed uninhabitable by the transitional housing provider due to safety or sanitary conditions. On March 8, 2024, TURA expressed its desire that trailers that are vacated not be reoccupied. The project site manager will notify TURA as trailers become vacant. When a trailer is ready for disposition, it will be disposed of in the following priority order.

#### For trailers that are habitable:

- Priority 1: Donation to transitional housing residents.

  Trailer(s) will be donated to residents occupying the trailer as participants of the Gateway Transitional Housing Program, at the time they move out of the housing program. A trailer tenant is not subject to the 10-day vacant policy as referenced above.
- Priority 2: Donation to non-profit that provides transitional housing services. Trailer(s) will be donated to a non-profit organization that provides transitional housing services in Jackson County.
- Priority 3: Donation to Jackson County Fire District 5.
   Up to three trailer(s) may be conveyed to Jackson County Fire District 5 for use in providing temporary housing for firefighters.
- Priority 4: Up to five trailers may be conveyed to the City of Talent for municipal use.
- Priority 5: Sale to the public, with proceeds used to cover costs associated with this Disposition Plan and expenses for maintenance and operating the units at the Gateway Project

For trailers that are not habitable and/or are not accepted as a donation:

- Priority 1: Donation to educational institution.

  Trailer(s) will be donated to an educational institution with a shop or similar program where students can gain educational benefit by renovating the trailer(s).
- Priority 2: Disposal.
   A contractor will be hired to decommission and dispose of the trailer(s).
